



Dental Hygiene Application Timeline

Deadline	Required Documents
First Friday in February	<b>Dental Hygiene Program application</b> (application via the Internet web page site)
First Friday in February	<b>\$25.00 Application fee</b> due with application forms. (Nonrefundable)
First Friday in February	<b>Confirmation of YVC College Application</b> unless currently enrolled.
First Friday in February	<b>*All official college transcripts</b> in duplicate through fall quarter of the year applying. Official YVC transcripts are not required. Unofficial YVC transcripts will be supplied by the college and submitted with the application materials.
First Friday in February	<b>High School transcripts/GED Certificate</b>
First Friday in February	Completed <b>Prerequisite Course Plan</b> <i>*Minimum 5 math/science courses completed by end of winter quarter</i>
First Friday in February	Proof of <b>Winter quarter registration</b> (if applicable)
First Friday in February	Completed <b>Dental Work Experience Verification forms(s)</b> – if applicable
First Friday in February	Completed <b>Dental Hygiene Observation form</b>
First Friday in February	<b>Official Second Language Testing (ALTA ) Completed</b> (Need not be fluent)
First Friday in February	<b>Health Sciences Reasoning Test (HSRT) Completed</b>
First Friday in February	<b>Personal Data Form</b>
First Friday in February	<b>Disclosure of Academic Performance</b>
First Friday in April	Students who have remaining prerequisite courses to complete during spring quarter must submit a copy of <b>spring quarter registration form</b> .
First Friday in April	<b>*Unofficial Winter quarter transcripts or grade slips</b>
First Friday in May	<b>*Official Winter quarter transcripts</b>
First Friday in July	<b>*Official Spring quarter transcripts</b>
First Friday in September	<b>*Official Summer quarter transcripts</b>

Send all application documents, including official transcripts, to the Dental Hygiene Department.

In order to be considered for the selection process, all documents must be received no later than the **first Friday in February**.

\*It is the applicant’s responsibility to verify that the YVC Dental Hygiene Department has received the documents prior to deadline dates. (509) 574-4916

\*To be considered official, all transcripts must be received by the Dental Hygiene Department in sealed, official school envelopes.

\*If transcripts are issued under a name different than the one referred to in the application process, it is the applicant’s responsibility to request the sending institution include the current applicant name on the transcript.
