Each FAFSA/WASFA cycle uses the financial information from two-years prior and the Financial Aid Office recognizes that a family's household or financial circumstance can change within that time frame and no longer be an accurate representation. On a case-by-case basis, the financial aid office may be able to adjust your FAFSA/WASFA application based on information provided to our office.

- A FAFSA or WASFA for the current award year must be processed and verified before an appeal can be considered.
- You <u>must</u> attach documentation and a detailed letter of explanation for the set of circumstances which you are appealing. Requests without documentation will be denied.
- Processing time may take four to six weeks. Requests are reviewed in the order which they are received. Adjustments to financial aid awards are made for the entire year including fall quarter if the student was enrolled and made academic progress. Generally, only one request will be considered each year. A status notification will be placed on your Student Portal when the request is approved or denied.
