Date	Important Date Information
Oct 23	Winter Quarter class schedule available on ctcLink.
Oct 23	Winter Quarter advance registration times available in ctcLink for currently enrolled students.
Oct 30	Currently enrolled degree/certificate seeking VA students eligible to register
Oct 31 – Nov 10	Advance Winter Quarter registration begins for currently enrolled degree/certificate seeking students.
Nov 20	Deadline: All transcripts (college and High School) must be received for Winter Quarter 2024 for full or part-time transfer student admission.
Nov 20	Deadline: Last day to apply and pay admission fee for Winter Quarter 2024 admission for new, *returning, and transfer full or part-time students seeking a degree or certificate.
Nov 13	Returning and transfer student (30+ college credits) Winter Quarter 2024 registration begins.
Dec 1	Deadline: Last day for students to complete placement (testing or High School transcripts) and schedule New Student Orientation appointment in Yakima and Grandview .
Dec 4	**Tuition due by 3:30pm for Winter Quarter 2024 if registered on or before this date.
Dec 7	New Student Orientation: By appointment only. Call the Admissions Office at 509.574.4712 for details.
Dec 11 – Dec 29	Winter holiday break- Limited college services available.
Dec 25	Christmas Day - Observed Holiday - College closed.
Dec 26 – Dec 29	Winter Quarter registration begins for part-time non-degree/certificate seeking students.
Dec 26	**Tuition due by 3:30pm for Winter Quarter if registered after December 4 th .
Jan 1, 2024	New Year's Holiday (observed) – College closed.
Jan 2	Winter Quarter 2024 classes begin.
Jan 2- 3	Current students can add a class without an instructor signature through their online ctcLink account.
Jan 4 – Jan 5	Students can add a class with instructor signature. Class adds must be completed on an Add/Drop Form .
Jan 2 – Jan 8	Refunds- 100% refund period ends on January 8 th .
Jan 2 – Jan 16	Students can drop a class in this period and the class does not appear on transcript. All drops after January 5 th must be completed on an Add/Drop Form and submitted to Registration.
Jan 12	Final drop for nonpayment process. Any classes added after this date will not be dropped for nonpayment. Student is responsible for all charges and nonpayment will result in tuition blocks and possibility of being sent to collections
Jan 16	Census Date- last day to adjust enrollment level for Financial Aid.
Jan 9 – Jan 23	Refunds- 50% refund period ends on January 23 rd .
Jan 17 – Feb 16	Students can withdraw from a class in this period and the grade appears as a “W” on transcript. Drops must be completed on an Add/Drop Form .
Jan 15	Martin Luther King Jr. Holiday - College closed.
Feb 5	Incomplete grades for Fall Quarter 2023 due in Records & Registration Office.
Feb 5	Summer Quarter 2024 graduation application deadline.
Feb 6	Advising Day – No day-time classes are held on advising day. Evening classes that begin after 6:30pm are held at their normal times. All Bachelor of Applied Science classes follow their regular schedule.
Feb 19	President's Day Holiday – College closed.
Feb 16	Deadline: Last day to withdraw from Winter Quarter. Drops must be completed on an Add/Drop Form .
Mar 1	Deadline: Last day to submit Winter/Spring/Summer 2024 degree/certificate applications to be included in the June commencement program.
Mar 11	Last day of classes for Winter Quarter.
Mar 13 – Mar 15	Winter Quarter final exams.
Mar 18	Grades due in Registration & Records Office by 4:00pm.
Mar 19 – Mar 29	Spring Vacation, limited college services available.
Mar 20	Grades available in ctcLink.

* Returning students are students who have not attended YVC for the last four or more quarters (not including summer).

** If you are receiving financial aid assistance you are responsible for verifying that your funds are ready to apply to tuition and fees. Currently enrolled students may be dropped from all classes if your tuition is not paid by this date.
